Payment of Tuition:

Tuition is due by the first of each month. If the accounts are not paid after the tenth of the month, there will be a \$10.00 late fee for every week the balance goes unpaid. After 2 months of no payments and payment plan, your child will be unable to continue dance until all accounts are paid up. There is a \$35.00 returned check charge for any checks returned by the bank for any reason.

When costumes are ordered, I agree to pay the full amount of the costumes at the payment time. If my child drops or decides to not participate in the recital and costumes have been ordered for my child, I will still pay the amount of the costumes in full and receive no refunds.

Upon payment of the recital and registration fee, I agree to pay the full amount with the intention of my child participating in the recital. I understand that if my child does not participate in the recital, I will forfeit my recital fee and not be refunded for any purpose. If my account is not paid in full by May 10th and the time of recital, my child will be unable to participate in the end of year recital. Sharper Image Performance Dance Studio, Inc. reserves the right to disclose financial account information.

If I choose to pay the tuition in full for the year, I understand it is non-refundable even if my child decides to drop classes or quit and no credits will be administered for missed classes.

Covid-19 Procedures for Returning to Dance

Student Requirements:

- All students will have their temperature checked upon entering the dance studio. If a student's temperature exceeds 100.4 they will be sent home for the day.
- All students will be required to wash their hands (for 20 seconds) before entering the dance/tumble room.
- Upon entering and exiting the studio please no hugs 😊
- If a student is showing signs other than a high temperature such as coughing, sneezing, etc. The student will call their parent and will need to be picked up early.
- No masks are required by students, but welcomed if they feel more comfortable wearing one.
- Please bring a personal water bottle with your name on it. NO SHARING water bottles or snacks. The drinking fountain will be off limits to drinking out of, but can be used to refill your bottles.

Parent Requirements:

- Your student may enter the lobby 5-10 minutes prior to class beginning. Please also pick your student up on time. We do not want students "hanging" out just to be with their friends. If a student has multiple classes and has to wait between classes that is fine as long as they social distance in the lobby. If they cannot social distance in the lobby then a mask is recommended.
- Parents **MUST** remain in their car during class. This eliminates congregation in the lobby and allows us to make room for more of your students. If you have to use the restroom that is fine then just return to your cars.
- Only two parents are allowed at a time in the lobby to speak with Ms. Diana and to make payments.
- We will still accept check or cash. If it is easier, you may mail it in or send it in with your student. Please provide your own pen when filling out information if you can.
- Please keep your student home if they are not feeling well. Better be safe than sorry. We can always make up classes.

Studio Requirements:

- Social Distancing is required in the lobby and promoted in the studios
- Bars and mats will be sanitized in between each class that they are used
- Studio doors will be left open to promote better ventilation and reduce the use of door handles
- Plexi-glass shield will be at the front desk
- Teachers will wash their hands in between each class and also have their temperature checked upon entering
- Please no students or parents behind the desk
- There will be no public coloring books or crayons for use
